Parents who both work or single working parents can receive a child care refund from the Dutch tax authorities, dependent on their salary level. Parents and their child(ren) need to have a 'burgerservicenummer' and parents have to work (part-time) or study in The Netherlands. Even those who do not pay tax in The Netherlands might be eligible to receive a refund.

General Terms and Conditions

A. Enrollment and its consequences

1. The enrollment of a child will only be taken into consideration by Fun4Kids upon receipt of a completed 'Summer Camp Enrollment Form 2018'.
2. Only complete and signed enrollment forms will be considered for application for a place at Summer Camp.
3. The requested summer camp week(s) for the child must be indicated on the enrollment form.
4. Fun4Kids has no obligation to admit a child who applies for a place at Summer Camp and is not obliged to justify its decision not to admit a child.
5. Enrollment is subject to availability. A waiting list is established on a first come first served basis when Fun4Kids is fully subscribed for any particular week.
6. Enrollment is only confirmed and a place at Summer Camp guaranteed once full payment has been received.
7. Fun4Kids reserves the right to terminate the Enrollment Agreement with immediate effect, without any recourse to the courts and without any damages whatsoever to the child's parent(s)/guardian(s) if the child or child's parent(s)/guardian(s) fail to reasonably behave, co-operate and accept camp rules and guidance. The termination of the Enrollment Agreement will result in the immediate expulsion of the child from Summer Camp.
8. Fun4Kids reserves the right to use images of children engaged in activities or related events in Fun4Kids related media, such as the Fun4Kids webpage or in Fun4Kids promotional material. In the event that a parent/guardian does not want their child's image used in Fun4Kids related media the parent/guardian must notify the Summer Camp co-ordinator in writing.

B. Fees

8. Fees are invoiced based on the weeks requested on the enrollment form. Fees are per full week.
 - Summer Camp (8:00-15:30) € 240.00
 - Additional hours (15:30 – 18:30) € 24 per day (available Tuesdays and Thursdays only)
9. Parents/guardians will be invoiced once an Enrollment Form has been completed. Enrollment is only confirmed and a place at Summer Camp guaranteed once full payment has been received.

11. The Fee covers all supplies, activities, meals & snacks, excursions and workshops.

12. The Fun4Kids Summer Camp qualifies for the Dutch Childcare Allowance (Kinderopvang toeslag). Childcare allowance is available for parents that are (temporarily) working or studying in the Netherlands, irrespective of nationality or type of childcare they choose to use; daycare, after school care and childminders. Childcare allowance is also available for tax exempt residents, for example diplomats and employees of international organisations. Childcare allowance is available for children up to age 12. 13. Cancellation & refunds

In case of withdrawing your child after the registration is complete, a refund will be made as follows:

- * If cancellation is made before 15 June, a 100% refund will be made.
- * If cancellation is made before 1 July, a 50% refund will be made.
- * If cancellation is made after 1 July, NO refund will be made.
- * There are no refunds for sick days, late arrivals, early departures or any missed day.

14. Late collection

Parents/guardians of participants enrolled at Fun4Kids will be charged a fine when picking up their child(ren) late.

The amount of the fine is as following;

*€15,- per hour during Funtazia International Child Care opening times (between 15:30 & 18:30).

*€15,- per 15 minutes, after Funtazia International Child Care opening times (after 18.30).

C. Application of the general terms and conditions

15. These general terms and conditions apply from the moment the child's parent(s)/guardian(s) submit an Enrollment Form until the child is no longer enrolled in Fun4Kids Summer Camp and all outstanding issues between Fun4Kids and the child's parent(s)/guardian(s) related to the child's enrollment are finally settled.

16. These general terms and conditions as well as the Enrollment Agreement to which they apply will be governed by Dutch law. All disputes arising out of or in connection with these general terms and conditions and with the Enrollment Agreements to which they apply shall be submitted to the exclusive jurisdiction of the courts of the Netherlands.

17. The invalidity or unenforceability of any provision(s) of these general terms and conditions shall in no way affect the validity or enforcement of any other provision(s) or any part thereof.
